- 1. Apologies: Angus Macpherson, Andrew Slaughter & Soren Hojlund
- 2. Approval of minutes from 6th December 2019 -
 - 1. Ewen pointed out an inaccurate description for point no 8 ie it should read 2020/21 cull targets.
- 3. **Chairman's Report** He appreciated that both Nicholas Wills and Freddie Macpherson could join the meeting thanks to Zoom
 - 1. The future of stalking this year was still unclear
 - 2. He reminded all about need to move on from lead shot
 - 3. He asked Sinclair to update the group.

4. SNH Report -

- The last helicopter count had been in 2016 and Covid 19 had stopped the planned one for 2020 - Sinclair confirmed the next helicopter count was now planned as a pri ority for South Ross & Knoydart in 2021
- 2. Lower carbon use is to be encouraged so longer term, there won't be helicopter sur-veys but possibly drones will be used or there will have to be more foot counts
- 3. Ammunitiion must be changed from lead to copper or lead-free. Copper is not stable at 243 grams, may have to be lowered to 75 or 85 g.
- 4. Guidance about best practice allowed to shoot deer to protect agriculture or forestry. Leisure allowed within 5 miles. Accompanied stalking not allowed, still waiting for update for future
- 5. Venison prices very low at present. Highland Game is not open for business yet, the challenge of social distancing when processing the meat. Simpsons is open.

Russell Cooper invited to comment from FLS:

- 1. Contract for venison sales with Highland Game but not open yet
- 2. Speculation about low prices for roe 65-85 p, red £1.10 £1.50

- 2. She will update hind cull from last year and the new counts that have been held
- 3. Add a summary of qualifications achieved
