1. Minutes of previous Zoom meeting on 1st December approved, proposed by Alec Cormack seconded by Ewen Macpherson.

## 2. Chairman's Report & ADMG

AGM for ADMG emphasised importance of climate emergency. Scottish Government looking for a new Natural Environment Act to include a deer element rather than a separate new Deer Act to be passed in this session. Have accepted 92/99 of recommendations from the Deer Working Group. Impacts & outcomes very important.

#### 3. NatureScot Report

Sinclair Coghill gave a summary, again emphasised the Scottish Government's concerns about the biodiversity crisis & climate emergency means it is looking for increased speed in Strategic Deer Board will be driving this forward, joining up all the government agencies. New Scottish Biodiversity Strategy - overarching targets - preventing biodiversity loss by 2030 (looking at upland habitats being low) and restoration by 2045.

Legislative change coming in Natural Environment Bill

Significant review of Wild Deer Strategy will be carried out - but after the above legislation introduced

Strategic priorities of climate emergency & biodiversity emergency

Deer & Green Recovery

Deer & Carbon

Deer & Public Safety

Deer & Impacts

Deer Strategy Round Table will continue to be conduit for engaging stakeholders Specifics:

Trials of Image intensifying devices - concluded end of March, need parliamentary approval

Non Lead - shortage of copper ammunition - not yet required legally, requested by game dealers but lack of availability. Legislation will follow later.

Counting deer - still continuing but keen to reduce carbon footprint, 7% of NS's due to helicopter counts. Trialling drones, satellite imagery, AI to identify deer.

10 deer per km2 recognised by Scottish Government but varies on local conditions, NatureScot recommends need to aim for that level. Lengthy discussion followed.

Herbivore impact assessments - emphasised essential to keep it recorded and up to date

# 4. Landscape Scale Deer Populations & Planning - Paper for discussion provided by Linzi Sievwright

Benefit of data collected since 2016 on a landscape scale to map information, to encourage discussion as about to revise & refresh deer management plan

Ensure when modelling predicted 6.1 but in reality 11.3 suggests from point of view of Affric - attempt by Strathfarrer Group to reduce hind numbers so pushed into other hot spots. Maps provided indicates that a decrease in hinds encourages more stags move in, displaces and changes dynamic.

Main problems arise with stags being in wrong place at wrong time.

Problem large numbers of stags in South Affric, bring down numbers where too many hinds.

Need to work collectively in future

Important to bring down numbers across the SAC, bear in mind where culls going to be held, leads to increase deer elsewhere. Not just the SAC

Shared population across the area, need to plan collectively as a larger group.

Willie Fraser emphasised need to work together for the bigger picture. Domino effect. Important to consult each other. Planning process needs to include every group, understand impact of culling strategy....Lochalsh needs to increase its cull.

Collective cull should be planned together

Meet after deer counts on the ground, suggest South Ross Liaison Group should meet Spot counts in winter are not accurate. Recruitment count late May

Starting count 2021 - Linzi suggests count up total planned cull, with overarching target density rather than just each local estate's planned cull. The key is the hinds. Agree to work together.

Meet after the stags with their intended cull figures for hinds, Linzi will feed it in before. LDMG will meet at Inverinate. LS will liaise. Russell suggested the hind figures will be available before end of stags, to help get a clearer picture. General agreement forecast for 1 June with initial planned cull from individual estates to LS.

Not the final answer but beginning of the process.

SC emphasised need to focus on hind numbers
